1: አጭር ርዕስ

ይህ አዋጅ "ክልሉ ውስጥ ማስታወቂያዎችና ቢሮዶች በሰማሌ ቋንቋ ታትሞ እንዲሞሉ ለመድንገግ የወጣ አዋጅ ቁጥር 200/2013 ተብሎ ሊጠቀስ ይችላል።

2. Qeexid

Hadii aan haboonaanta craygu macno kale siinin, Bayaankan dhaxdiisa:

1. "Dastuur" waxaa loola jeedaa Dastuurka Dib loo habeeyay ee Deegaanka Soomaalida.
2. "Deegaan" waxaa loola jeedaa Deegaanka Soomaalida.
3. "Xayaysiisyada Ganacsi" Waxaa loola jeedaa dhamaan boodhadhka lagu qoro guud ahaan ama qayb ahaan Magaca, Calaamada, Astaanta ama arrimaha kale ee la xidhiidha Ganacsiga ee lagu dhejiyo goobaha wadooyinka.
4. "Qof" Waxaa loola jeedaa Qofka bani'aadamka ah iyo waxyaabaha kale ee sharcigu siiyay jiritaan sharci.
5. "Xafis" Waxaa loola jeedaa Xafiiska dhaqanka iyo Dalxiiska ee Dawlada Deegaanka Soomaalida.

2: ትርጓሜ

የቃሉ አገባብ ሌላ ትርጉም የሚያሰጠው ካልሆነ በስተቀር በዚህ አዋጅ ውስጥ:-

1. "ህገ-መንግስት" ማለት የተሻሻለው የሰማሌ ክልል ህገ-መንግስት ማለት ነው።
2. "ክልል" ማለት የሰማሌ ክልል ማለት ነው።
3. "የንግድ ማስታወቂያዎች" ማለት በሙሉ ወይም በከፊል ስያሜው፣ የንግድ ምልክት ወይም ሌሎች በንግድዎች ላይ በሚለጠፉና ከንግድ ጋር የተያያዙ ማስታወቂያዎችና ቢሮዶች ነው።
4. "ሰው" ማለት የተፈጥሮ ሰው ወይም በህግ የሰውነት መብት የተሰጠው ነው።
5. "ቢሮ" ማለት የሰማሌ ክልል ባህልና ቱሪዝም ቢሮ ማለት ነው።

3: ስለአዋጁ ዓላማዎች

የአዋጁ ዓላማ በንግድዎችና በሌሎች ቦታዎች የሚለጠፉ ማስታወቂያዎች የሰማሌ ማንነትና መልካም ባህልን በግልፅ የሚያሳዩ መሆናቸው በማረጋገጥ የተሻሻለው የሰማሌ ክልል ህገ-መንግስት አንቀፅ 6ን ተግባራዊ ለማድረግ ነው።

3: Ujeedada Bayaanka

Ujeedada Bayaankani waa in Xayaysiisyada iyo Boodhdhka kala duwan ee lagu dhejinayo wadooyinka iyo goobaha kale ay noqdaan kuwo si cad u muujinaya astaanta Soomaalinimo iyo Dhaqanka suuban islamarkaana la hirgeliyo Qodobka 6^{aad} ee dib loo habeeyay ee Dastuurka Dawlada Deegaanka Soomaalida.

4: የተፈጻሚነት ወሰን

ይህ አዋጅ በማንኛውም በሰማሌ ክልል የሚኖርና ማስታወቂያ ለማውጣት የሚፈለግ ሰው ወይም ህጋዊ አካል ተፈጻሚ ይሆናል።

4. Xadka Dhaqangalka

Bayaankani waxa uu dhaqangal ku yahay qofkasta oo ku nool Deegaanka Soomaalida oo raba inuu daabacdo ama soo saaro Boodh ama Xayaysiis.

**PART ONE
GENERALITY**

1. Short Title

This Proclamation may be cited as the "Proclamation to proclaim Using of Somali Language for Advertisements And Billboards" Proclamation no- 200/2021.

2. Definition

In this Proclamation, unless the context otherwise requires:

1. "Constitution" means the Revised Constitution of Somali Region.
2. "Region" means the Somali Regional State.
3. "Commercial Advertisements" means boards posted in streets containing the whole or part of the business name, trademarks or other matters related with the business.
4. "Person" means natural or Juridical person.
5. "Bureau" means the Somali Regional state Bureau of Culture and Tourism.

3. Objective of the Proclamation

The objectives of this proclamation shall be to ensure Billboards and advertisements posted in streets and other places clearly display core values of the Somali identity and to ensure article 6 of the Somali Regional State Revised constitution is implemented and translated into practice.

4. Scope of Application

This proclamation shall be applicable to any person residing in the Somali Region who wants to produce and printing of advertisement or boards.

5. Afka lagu qorayo Xayaysiisyada iyo Boodhadhka

1. Qofkasta oo ku nool deegaanka oo Boodh ama Xayaysiis daabacanaya waxaa waajib ku ah inuu ku qoro Af-Soomaali
2. Iyadoo ay sideeda tahay Arrimaha lagu xeeriyay Qodob hoosaadka (1) ee Qodobkan, Qofkasta oo raba inuu Luuqad kale ku daro Boodhka ama Xayaysiiska uu daabacanayo waa inuu ogolaansho ka helo Xafiiska.
3. Shirkadaha Daabacaada ka shaqeeya ee Deegaanka waxaa waajib ka saaranyahay inay saxaan islamarkaana Hubiyaan in Boodhadhka iyo Xayaysiisyada ay Daabacayaan ay waafaqsanyihiin Bayaankan.

QAYBTA SADEXAAD

6. Waajibbaadka Maamulka

Magaalada iyo Dawlada Hoose

1. Hab waafaqsan Awaamiirta uu soo saaro Xafiisku Maamulka magaalada iyo Dawlada hoose waxaa waajib ka saaranyahay inay jidadka soo gala Magaalooyinka ku dhejiyaan Boodhadh ay ku qorantahay Magaalada magaceeda iyo soo dhaweyn.
2. Maamulada Magaalooyinka iyo Dawladaha hoose waxaa waajib ka saaranyahay inay xaqiijiyaan in dhamaan Boodhadhka iyo xayaysiisyada lagu dhejiyo goobaha kala duwan ee magaaladu ay waafaqsan yihiin Bayaankan, Xeeridaameedka iyo Awaamiirta loo soo saaro hab waafaqsan.

7. Arrimaha la xidhiidha Magacyada iyo Astaamaha

Si loo xoojiyo jiritaanka iyo Kobaca Afka Soomaaliga, Xeeridaameedka uu soo saaro Golaha hawlfulinta ayaa lagu faahfaahin magacyada iyo Astaamaha loo isticmaali karo xayaysiisyada iyo boodhadhka ganacsi.

5: ግስታወቂያዎችን ቢሮዶችን ስለግወጣት

1. በክልሉ ውስጥ ግስታወቂያዎችንና ቢሮዶችን ለማሳተፍ፣ መጠቀም የሚፈልግ ማንኛውም ሰው ስማልኛ ቋንቋን የመጠቀም ግዴታ አለበት።
2. የዚህ አንቀጽ ገዕብ አንቀጽ (1) አንዳተጠብቀ ሆኖ ሌላ ቋንቋ ማካተት የሚፈልግ ማንኛውም ሰው ከቢሮው ፈቃድ መግኘት አለበት።
3. በክልሉ ውስጥ ግስታወቂያዎችንና ቢሮዶችን በማምረት ላይ የተሰማሩ ድርጅቶች ግስታወቂያዎች እና ቢሮዶችን በዚህ አዋጅ መሠረት አንዲያመረቱ የማረጋገጥ ግዴታ አለባቸው።

6: የከተማ አስተዳደርና የከተማ አገልግሎቶች ግዴታዎች

1. የከተማ አስተዳደርና የከተማ አገልግሎቶች ባወጡት ህጎች መሠረት ወደ ከተማው የሚገቡ መንገዶች የከተማዋን ስያሜ የሚያሳዩ ቢሮዶችን ለይ የአንኳን ደሀና መጣቸው መልእክት የመለጠፍ ግዴታ አለባቸው።
2. የከተማ አስተዳደርና የከተማ አገልግሎቶች በከተማው የተለያዩ አካባቢዎች የተለጠፉ ሁሉም ማንኛውም ቢሮዶችና ግስታወቂያ ይህንን አዋጅና ለዚህ ዓላማ የሚወጣውን ደንብ ላይ የተመሠረተ መሆኑን የማረጋገጥ ግዴታ አለባቸው።

7: ከስያሜዎችና ምልክቶች ጋር የተያያዙ ጉዳዮች

የሰማልኛ ቋንቋ ሁለንተኛ ዕድገትና ማብልጸግ ለማረጋገጥ፣ በሥራ አስፈጻሚ ምክር ቤት በሚወጣው ደንብ መሠረት ለግስታወቂያና ለቢሮዶች አገልግሎት የሚውሉ ስያሜዎችና ምልክቶችን በዝርዝር ያቀርባል

PART TWO

5 Language used for producing boards and advertisements

1. Any person residing in the Region and wants to print advertisements and boards is required to use Somali language for it.
2. Notwithstanding to the provisions of Sub Article (1) of this article, any person who wants to include additional languages to the boards and advertisements is required to obtain permission from the Bureau.
3. Printing Enterprises operating in the Region shall have the obligation to verify and ensure that billboards and advertisements they produce are in line with the provisions of this proclamation.

PART THREE

Article 6 Obligation of City Administrations and Municipalities

1. In accordance with directive issued by the City Administration and Municipalities shall have obligation to write name of the cities and welcoming messages on boards post on entrance roads leading into the city.
2. City Administrations and Municipalities shall have obligation to ensure that all boards and advertisements posted in different parts of the city are in accordance with the provisions of this proclamation, regulation and directive issued as pursuant with this proclamation.

7. Matters Related with Designations and Symbols

To ensure enrichment and development of the Somali language, Designations and Symbols that can be used for boards and advertisements shall determined by the regulations to be issued by the Executive Council.

8. Ganaaxiyada

Qoofkasta oo lagu helo inuu ku xadgudbay arrimaha lagu xeeriyay Bayaankan iyo Xeeridaameedka iyo Awaamiirta loo soo saari doono hab waafaqsan Bayaankan waxaa loo ganaaxi hab waafaqsan Xeerka Dambiyada.

10. Awooda Soo saarista xeer

1. Golaha hawlfulintu waxa uu soo saari karaa Xeeridaameedyada lagama maarmaanka u ah dhaqangelinta qodobada Bayaankan.
2. Xafiisku waxa uu soo saari karaa Awaamiir lagu dhaqangelinayo Bayaankan iyo Xeeridaameedka uu soo saaro Golaha hawlfulintu.

11. Mudada Dhaqangalka Bayaankan

Bayaankani waxa uu dhaqangelayaa maalinta uu ansixiyo Golaha Kildhibaanadda ee Deegaanku.

8. Exemptions

This proclamation shall not be applicable to political organizations, religious organizations as well as federal entities and international organizations operating in the Region

PART FOUR

MISCELLANEOUS PROVISIONS

9. Penalties

Any person found guilty of violating the provisions of this proclamation as well as regulations and directives to be issued in accordance with this proclamation shall be punishable in accordance with the criminal code

10. Power to Issue Regulation and Directive

1. The Executive Council may issue regulations necessary for the implementation of this proclamation.
2. The Bureau may issue directives necessary for the implementation of this proclamation and regulations issued by the executive council.

11. Effective date

This Proclamation shall enter into force on the date of approval by the State Council.
